General Terms and Conditions

1. Scope

These general terms and conditions apply to all registrations, payments, and participation in activities, courses, and events organized by **Brussels Gay Sports ASBL**, a non-profit organization (NPO) under Belgian law.

By registering or participating, the member (or their legal representative) acknowledges having read and fully accepted these terms and conditions.

2. Membership and Registration

- Participation in activities is reserved for members of the association unless otherwise specified.
- Registration is only final after receipt of the registration form and payment.
- The association reserves the right to refuse registrations if the maximum number of participants is exceeded or for other legitimate reasons.

3. Prices and Payment

- Prices are stated in euros and include any administrative fees unless otherwise indicated.
- Payment must be made within the timeframe specified by the association. In case of late payment, the registration may be canceled without further notice.
- As the association does not conduct commercial activities, VAT is not applicable except in cases provided for by law.

4. Cancellation and Refunds

- Cancellation by the participant must be communicated in writing (by email or letter).
- In case of cancellation up to 14 days before the start of the activity, the registration fee will be fully refunded minus an administrative fee.
- In case of cancellation within 14 days of the start date, no refund will be made unless a valid medical certificate is provided.
- If the association cancels or modifies an activity, the full amount will be refunded.

5. Liability

- The association organizes its activities with the utmost care but cannot be held responsible for accidents, loss, theft, or damage to personal belongings.
- The participant (or their legal representative) remains liable for damage caused to third parties or to infrastructure used during activities.
- The association is insured for civil liability through a group insurance policy with Ethias.

6. Use of Infrastructure

- The association uses external venues (sports halls, community centers, schools, etc.) where specific house rules may apply. Participants agree to comply with these rules.
- Damage caused by participants may lead to personal liability and/or exclusion from further participation.

7. Photos and Videos

- Photos and videos may be taken during activities for promotional purposes.
- By participating, the member (or their legal representative) grants permission for the use of such images unless they expressly object in writing.

8. Privacy Policy

- The association respects the privacy of its members and processes personal data in accordance with the General Data Protection Regulation (GDPR).
- All administration and processing of personal data takes place within the application Twizzit. The privacy policy is consultable within this application.

9. Force Majeure

 In cases of force majeure (such as pandemics, natural disasters, government measures, or venue unavailability), the association may cancel or reschedule activities without owing compensation.

10. Dispute Resolution

- Any disputes will first be subject to an attempt at amicable resolution.
- If no agreement is reached, the courts of the judicial district where the association's registered office is located will have exclusive jurisdiction.
